WHO WE ARE

CORDEV is a small-business prime with 38 years of Army installation IT and telecommunications past performance. The scope is the communications squadron mission, installation telecom plant and enterprise network operations at the garrison. Primes team with CORDEV to add installation-IT depth and a retention record to the bid. On the IMCS program, CORDEV has retained every task order it has won at least once at recompete. CORDEV's most recent task order closed in November 2025, when the Air Force assumed the joint base scope at Fort Dix; the work transferred to the customer, not to a competitor. The IMCS IV vehicle and GSA MAS schedule are active, and CORDEV staffs new work through incumbent capture and rapid stand-up.

WHAT WE BRING TO A TEAM

CORDEV is looking for two kinds of primes: those whose customer base would expand our profile beyond Army installations, and those whose specialized technical scope (AI, data engineering and analytics platforms, advanced cyber, other modernization work) calls for the installation IT and telecommunications operations and maintenance CORDEV already delivers. CORDEV brings a cleared, Army-seasoned workforce and scope depth; the prime brings the customer relationship or specialized technical capability CORDEV does not build in-house at scale. Neither side is supplying what the other already has.

AWARD-TO-START RECORD

At Aberdeen Proving Ground, CORDEV onboarded 51 cleared full-time equivalents in five business days and fielded vehicles, tools, and TMDE within 10 business days, from Friday award through Monday start, with no phase-in period.

CAPABILITY DEPTH

IT: Tiers I – III help desk, network and systems administration, asset lifecycle, patch and vulnerability management (ACAS, HBSS, STIG, eMASS), account provisioning, VTC support.

Telecommunications: unified communications including Avaya call servers, VoIP infrastructure, DSN trunking, and endpoint administration; inside and outside plant O&M and infrastructure; Land Mobile Radio including tower infrastructure, master controller, subscriber units, and network management, with microwave and mobile satellite communications and spectrum management support.

Fort Campbell, KY (2008 – 2019). Unified ATS and IT services across a standalone contract, an IMCS II task order, and a bridge period; 53 FTEs; \$51.6 M combined; 30,000+ users. CPARS consistently Exceptional in Quality, Schedule, Cost Control, and Management; Outstanding COR reports; 84% workforce retention across the full 11 years.



Which means the team responding to the 0200 network outage already knows the topology, the equipment, and the workarounds.

Fort Benning, GA (2011 – 2020). Two consecutive task orders; 35+ FTEs; \$45 M combined; 43,000+ users. Benning ran outside plant and inside plant on separate contracts, with predictable disputes, before CORDEV consolidated both and closed the gap. Retained the work through the recompet boundary between the two task orders.



Which means a prime bringing CORDEV into a consolidated scope is bringing a contractor that has already run the consolidation playbook, not one improvising it.

Fort Bliss, TX (2015 – 2023).

Continuous performance across eight years; 55 FTEs; \$33.9 M combined; 40,000+ users. CORDEV operated enterprise IT at the cantonment and Land Mobile Radio O&M at White Sands under the same contract and the same leadership, as a single integrated service covering tower infrastructure, master controller, subscriber units, and network management.



Which means the LMR network was operated as mission-critical range communications where an outage halts live firing.
